Ms. Luz Holguin and Mr. Luis Loya provided a presentation to the Board regarding this item (copy on file in Central Files.) EPWater has been a long-term community partner supporting charitable organizations since its inception in 1952. The Public Service Board (PSB) approved the Strategic Partnerships and Alliances with Non-Profit Organizations Administrative Policy in 2009. This Policy allows the PSB to select one charitable organization yearly for a fundraising project led by EPWater employees. EPWater receives requests throughout the year to support local and charitable causes. Ms. Holguin and Mr. Lopez answered questions from the Board on this item.

On a motion made by Ms. Saenz, seconded by Mr. Morris, the Board approved the selection of SK8 4KIDS as the Utility's Strategic Partner for 2024.

Geoffrey Espineli, Utility Engineer Division Manager provided a presentation to the Board regarding this item (copy on file in Central Files.) The three lift stations at Prado, Knowles and Mansfield were built in the 1970s. All lift stations are located and serve the Mission Valley area of El Paso and have exceeded their design life. This project will reconstruct Prado and Knowles lift stations. The new lift stations will include a new wet well, pumps, electrical equipment, a control building, and site improvements. The Mansfield lift station will be decommissioned and will be replaced with a new 7,000-feet of 15-inch gravity pipeline along Yarbrough and Independence streets. Mr. Espineli answered questions from the Board on this item.

On a motion made by Ms. Saenz, seconded by Dr. Gitter the Board awarded Bid Number 05-24 Prado & Knowles Lift Stations Reconstruction, Mansfield Lift Station Decommissioning, Independence Interceptor to the lowest, responsive, responsible bidder Smithco Construction, Inc. in the amount of \$8,488,131 and authorized the use of commercial paper.

Jeff Tepsick, Utility Assistant Chief Financial Officer, provided a presentation to the Board regarding this item (copy on file in Central Files.) Chapter 105 of the Texas Government Code requires EPWater to request, receive and review applications for the performance of depository services from financial institutions for banking services at least once every five years. EPWater issued a Request for Application Primary Depository Services Request for Applications RFA 69-23. EPWater contracted with Valley View Consultants to assist EPWater with the Request for Application process.

On a motion made by Dr Santiago, seconded by Dr. Gitter, with Mr. Morris opposing and Ms. Saenz abstaining, the Board adopted a Resolution of the El Paso Water Utilities Public Service Board designating Wells Fargo Bank, N.A. to serve as the depository for El Paso Water Utilities funds and to provide banking services based on the application received in response to RFA Number 69-23 Bank Depository Services for a two-year term with an option to renew for three, one-year extensions and authorized the President/CEO to negotiate and sign any and all related documents and agreement related to this designation.

Alejandro Vidales, Assistant Utility Land and Water Rights Manager, provided a presentation to the Board regarding this item (copy on file in Central Files.) On February 12, 2020, the Public Service Board (PSB) determined the land totaling approximately 20,948, and legally described as consisting of all or partial sections of Township 7 and 8, Block 65, and all or partial sections of PSL, Block 77, and PSL Part I and PSL Part II, Block 63, also known as the Wild Horse Ranch, Culberson County, Texas, to be inexpedient to the water and wastewater systems. On March 13, 2024, the Public Service Board (PSB) determined the same land inexpedient to the stormwater system. This land is in Culberson County, Texas.

On a motion made by Ms. Saenz with an modification that the property be sold for an amount no less than \$6,000,000, seconded by Mr. Morris, the Board adopted a resolution accepting Tres Aguilas Farm and Ranch, LLC.'s, offer to purchase approximately 20,948 acres of Utility property in Culberson County, Texas, consisting of all or partial sections of Township 7 and 8, Block 65, and all or partial sections of PSL, Block 77, and PSL Part I and PSL Part II, Block 63, also known as the Wild Horse Ranch, for an **amount no less than** \$6,000,000 and authorize the President/CEO to forward the recommendation to City Council, and to sign any and all documents necessary to complete the sale.
